#### □ Exemption by Descent

Is granted to a direct descendent of a person (principal citizen) who was considered a Citizen of Fiji on the 10<sup>th</sup> of October, 1970 and holder of a valid foreign passport to enter, reside, study and work in the country. Direct descendants include the principal citizen's children, grandchildren and great grandchildren.
